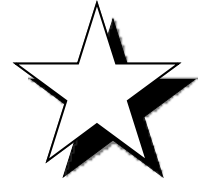
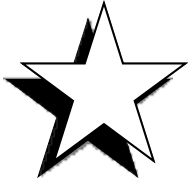

CONDITIONS

1. The tournament will be conducted under the Rules of Lawn Tennis and the rules and regulations of the LTA including the Code of Conduct.
2. A County qualification is not required but all matches must be played within the geographical boundaries of Kent unless mutually agreed by the two players. (This is the County of Kent, the London Boroughs of Bexley, Bromley, Greenwich and Lewisham and the Unitary authority of Medway).
1. Competitors must attain the minimum age on 1st September 2010 – i.e. A junior player entering an Under 12 event must **not** have reached their 12th birthday before 1st September 2010. Ladies must have reached their 40th birthday, or Men their 45th birthday before 1st September 2010 to enter the Veteran events.
2. In the Parent and Child event the 'child' must be over 12 years of age on 1st September 2010.
3. The 9 & Under and 10 & Under events will be for both boys and girls.
4. **PLAYERS MAY ONLY ENTER A MAXIMUM OF 3 EVENTS**
5. **Players must be available for the Finals Day – Sunday March 27th 2011.** No exception to this rule is allowed. If for any reason it becomes clear that a player will not be available on Finals Day they must withdraw from the competition **immediately**. Failure to do so will result in disqualification. Any matches played and won knowing that a player will be unavailable for Finals Day will be declared null and void (i.e. as if it had never been played)
6. New balls of a make designated as within ITF specifications and (unless from a freshly opened pressurised container) of the current year shall be provided at the expense of the players with choice of ground, unless mutually agreed otherwise. Balls will be provided for the Finals.
7. Scoring format: Senior Matches - The best of 3 tie-break sets. The 3rd set can be replaced by a champions tie-break game (first to 10 points with a lead of 2 points) only if it is mutually agreed before the commencement of the match. If players cannot agree a third tie-break set must be played.
All Junior matches must adopt the champions tie-break game in place of the 3rd set.
12 & Under matches will be abbreviated scoring (sets to 4) with a champions tie-break 3rd set
9 & Under and 10 & Under scoring system will be advised later
8. Arranging matches: Once a date has been fixed for a match it cannot be changed other than for bad weather. If a player cannot make the pre-arranged date for any other reason then they must concede the match.
9. Players will be given play-by dates to complete their matches. These must be adhered to. If players wish to extend the date they must ask permission from the organisers. Failure to do so could mean both players/teams are disqualified from the event.
10. **Closing Date is 9th October 2010.**
11. The decision of the Referee is final. No complaint can be entertained unless lodged in writing with the Tournament Organiser within 48 hours of occurrence.
12. Players enter the Competition at their own risk. The host clubs shall not be held responsible for personal injury or loss or damage to personal effects.
13. **No entry will be accepted without the appropriate entry form and fee. No late entries will be accepted. No telephone entries will be accepted.**
14. **Entries will be confirmed by email.**
